#### **Visitor centre**

We have had further electrical safety inspections carried out to all outside electrical areas as part of the Councils new safety measures.

### **Site Works**

- Ongoing litter picking in the park and on the cycle-route.
- The heavy snow before Christmas caused major tree damage in the park and along the cycle route. We spent three days clearing fallen trees along the cycleway just to make it safe to use and there is probably another months-worth of work needed to clear other fallen trees and generally tidy up, a job which we have already started.
- High winds have also caused significant damage to trees
- The heavy rains have meant that we have had to carry out lots of ditching works and unblock culverts.
- Chipping fallen trees.
- Ogilvie Olympics repairs: Awaiting contractor.
- o Dragonfly: Waiting for lake water levels to drop before fitting.
- o Coot benches: Awaiting fitting.
- New lakeside bins delivered, awaiting fitting.
- About 95% of the timber has been removed from the storage area opposite Prices Yard.
- New Compost toilet: Meeting contractor next week for fitting prices.
- Park Services are thinning the trees along the inflow channel to the lake in the New Year.

#### **Events**

All three Christmas events were full booked and went really well apart from some disruption because of the snow.

Next week we will be sitting down to plan the summers events program.

Amphitheatre Animal sculptures: I am awaiting designs from the artists. These should be with me by next week.
