A casual vacancy had been advertised and a letter of interest had been received from Mrs Roderick. Members considered this application and approved the co-option of Mrs Roderick to the Council, Mrs Roderick took the oath of office.

3739 Matters arising

Brithdir lights, a member had bought a 5 foot tree and some lights and this will be set up in order to put up a display. The reason for this was discussed and it was reported tat the shrubs in the areas which had previously been used had been severely cut back and the regrowth would be inadequate to carry the display this year. It was suggested that the regrowth will be inadequate next year too, so it will need to be addressed later in 2019 before the festive season.

It was reported that the Phillipstown school power supply was not suitable for a display. The living tree had been planted and it was hoped that solar lights would be set up hopefully in a few days.

Some email correspondence between the clerk and Elsbury was reported. It was agreed it was disappointing that some of the lights which were relatively new had started to fail. Further details should be requested
